- Approved helmets and apparel, in accordance with Schedule D of the Motorsport Australia Manual.
- Fuel must be in accordance with Schedule G of the Motorsport Australia Manual.
- Cars must be adequately muffled.
- Competitors must produce a valid and current:
  - Motorsport Australia Competition Licence
  - Club Membership Card of a Motorsport Australia Affiliated Car Club
  - Log Book (if issued)

<b>The manner in which the results will be determined, and prizes awarded</b>	<p>Results shall be determined by the lowest aggregate of elapsed times on the tests completed, inclusive of penalties.  All times on each test will count.  Timing shall be to 0.01 Second.</p>

<b>OTHER EVENT REQUIREMENTS</b>	<p>The event will be held on a dirt surface. The event will consist of a minimum of 4 Khanacross tests. Classes will be as per the 2024 NSW Khanacross Addendum. The event timekeepers will act as the Judges of Fact. The Judges of Fact will be identified at the drivers briefing. The Facts to be judged include Start/Finish Procedure, valid course attempts and application of penalties. This Event will include a Motor Sport Passenger Ride Activity (MSPRA) which shall be run under and in accordance with the Motorsport Australia MSPRA Policy.</p>

- The Organisers may refuse any entry in accordance with NCR.
- Entries from competitors under 18 years of age must be counter signed/consented to by a parent/guardian.
- The Organiser reserves the right to abandon, postpone or stop the Event in accordance with the NCR.
- Protests must be lodged in accordance with the NCR.
